



## **HealthChoices Expansion**

May 1, 2015

On April 27, Pennsylvania took a major step forward in completing a traditional Medicaid expansion. The Department of Human Services (DHS) successfully moved 121,234 individuals from the previous *Healthy PA* plan to the comprehensive Adult benefit package delivered through the traditional HealthChoices Medicaid managed care program. This transition provides greater health care coverage in a simpler and streamlined manner to Pennsylvanians who are most in need.

## **HealthChoices Expansion: Phase One Implementation**

- DHS discontinued the Interim Healthy and Healthy Plus benefit plans and moved all individuals in these plans to the single Adult benefit package.
- DHS transferred individuals enrolled in the *Healthy PA* Private Coverage Option (PCO) into the HealthChoices Adult benefit package. This group includes PCO recipients enrolled in Medicaid as of Dec. 2014.
- The "front door" to the PCO is closed, as of April 27, 2015. DHS will place all newly eligible adults in Medicaid and enroll these individuals in HealthChoices instead of the PCO.

As of April 30, Pennsylvania enrolled 10,536 newly covered individuals into HealthChoices. 133,304 individuals remain enrolled in the PCO, and will gradually transition to HealthChoices over the next few months. The transition will be complete and their new coverage in the HealthChoices plan will begin by September 1.

"Thank you to all the DHS staff that worked some very long hours to implement this phase of the Medicaid expansion," said Acting DHS Secretary Ted Dallas. "Their teamwork is a great example of what the Governor means when he says that his Administration will be a government that works."

## **Impact: Support from the Community**
